Nevertheless, there has been substantial discussion about empirical evidence justifying this conclusion." (Cornell Law School)

## A REFRESHER ON THE FIRST AMMENDMENT...

"Congress shall make no law respecting an establishment of religion, or prohibiting the free exercise thereof; or abridging the freedom of speech, or of the press; or the right of the people peaceably to assemble, and to petition the Government for a redress of grievances."

### - from the American Bill of Rights

## **And who is protected under the First Amendment?**

**States, documented or otherwise! \***

"Freedom of speech is recognized as a human right under article 19 of the Universal Declaration of Human Rights."

**"The most basic component of freedom of expression is the right to freedom of speech."**

**A QUICK BREAKDOWN OF THE FIRST AMENDMENT'S TEXT:**

"The First Amendment of the United States Constitution protects the right to freedom of religion and freedom of expression from governmental interference. It prohibits any laws that establish a national religion, impede the free exercise of religion, abridge the freedom of speech, infringe upon the freedom of the press, interfere with the right to peacefully assemble, or prohibit citizens from petitioning for a governmental redress of grievances."

**BUT...**

Disobedience is not protected under the First Amendment by the virtue of being classified as disobedience, as in the refusal to comply with a law as a means of peaceful protest ...

Disobedience is "A symbolic, non-violent violation of the law, done deliberately in protest against some form of perceived injustice. More dissent, protest, or disobedience of the law does not qualify. The act must be nonviolent, in and visible, legal, performed for the moral purpose of protesting an injustice, and done with the expectation of being punished."

## **FREEDOM TO ASSEMBLE**

"The right to assemble allows people to gather for peaceful and lawful purposes... Freedom of assembly is recognized as a human right under article 20 of the Universal Declaration of Human Rights."

LANDMARK DESICION

*Thomhill v. Alabama*, 310 U.S. 88 (1940). The Court ruled that peaceful demonstrators may not be prosecuted for "disorderly conduct." This case affirms that secured streets and sidewalks as public forums.

right of peaceable assembly and cannot be under state loitering and picketing laws.

**Edwards v. South Carolina**, 372 U.S. 229 (1963). In an 8-to-1 decision, the Supreme Court overturned the breach of peace convictions of 180 black students who had peacefully marched to the state capitol to protest discrimination.
